**Subject: Settlement of unsettled service period of Mr. Bashir Ahmad Dar, Associate Professor (English) Government Degree College, D.H Pura.**

Whereas Dr. Bashir Ahmad Dar, Associate professor (English) was transferred from Government College for Women, Anantnag to Government Degree College, Dooru vide Government Order No. 242-HE of 2009 dated 30.10.2009.

Whereas, Dr. Bashir Ahmad Associate professor (English) did not join at Government Degree College, Dooru and applied for medical leave and after expiry of the medical leave, he reportedly joined on 01.01.2011 in the personal section of the then Hon'ble Minister for Higher Education and remained attached there till 24.08.2011.

Whereas, Dr. Bashir Ahmad Associate professor (English) was posted at Government Degree College, Udhampur vide Government Order No.322-HE of 2011 dated 25.08.2011 on his request and the Higher Education Department has made a request to Shri Abdul Gani Malik, the then Minister for Higher Education vide letter No. HE-Coll/PF-65/English dated 20.03.2014 to intimate whether Dr. Bashir Ahmad was attached in his personal section w.e.f 01-01-2011 to 24-08-2011;

Whereas, Mr. Abdul Gani Malik, the then Minister for Higher Education has intimated vide his D.O Communication dated 19.06.2014 that the said Assistant Professor remained attached in his personal section for the period from 01.01.2011 to 24-08-2011;

Whereas, in order to settle the case the Department constituted a committee comprising of Director Colleges, FA/CAO and Nodal Principal to examine the un-settled service period w.e.f 01.01.2011 to 24.08.2011 of Dr. Bashir Ahmad Dar, Associate Professor(English), Government Degree College Udhampur.

Whereas, committee examined the case and observed that the period of attachment in the personal section of the then Hon'ble Minister without following proper orders of the competent authority cannot be considered as duty under rules and recommended that the unauthorized service period w.e.f 01.01.2011 to



24.08.2011 of Dr. Bashir Ahmad Dar Associate Professor (English), GDC Udhampur be treated as leave without pay.

Now, therefore, it is ordered that the unauthorized period of service of Dr. Bashir Ahmad Dar, Associate Professor (English) w.e.f. 01-01-2011 to 24-08-2011 shall be treated as leave without pay.
