Whereas, Higher Education Department has referred four posts of Library /RR Assistant (Divisional Cadre Jammu) to the Service Selection Board vide letter No: EC-Coll/NG/JK/2017 dated: 31-05-2017 for selection of suitable candidates.

Whereas, the Services Selection Board vide letter No. SSB/Secy/Sel/2019/283-89 dated: 09-01-2019 has furnished the selection alongwith waiting list of Library /RR Assistant Higher Education Department (Divisional Cadre Jammu).

Whereas, appointment order were issued in favour of below mentioned selected candidates vide Government Order No. 46-HE of 2019 dated: 01-02-2019 with the direction to report to the Director Colleges within a period of 21 days from the date of issuance of order:-

Whereas, Director Colleges vide his letter No: DC-HE/Appt/ Lib/RR. Asstt/2018 dated: 21-02-2019, has informed that the below mentioned candidates have not joined till date.

Whereas, Higher Education Department issued notice (through print media) vide letter No. HE/NGK/Lab.Astt/2018-19 dated: 27-06-2019 to the above candidates with the direction to join within a period of 10 days from the publication of notice, failing which their appointment shall be deemed to have been cancelled;

Whereas, the appointees failed to join within the stipulated time;

Whereas, appointment of Shivani Verma D/o Tarsem Lal Verma R/o Tilla Billawar Kathua, (OM) and Abda Shabnam D/o Ghulam Mohi Ul Din R/o Kalaban Mendhar Poonch (ST) was cancelled due to non joining of duties vide Government Order No: 74-JK (HE) of 2019 dated: 27-12-2019;

Whereas Higher Education Department has to operate waiting list of two candidates, whose selection/ recommendations has already been made/cleared by Services Selection Board vide letter No: SSB/Secy/Sel/2019/283-89 dated: 09-01-2019.

Now, sanction is hereby accorded to the temporary appointment of the below mentioned candidates as "Library/RR Assistant" (Divisional Cadre Jammu) in the pay scale of Rs. 5200-20200+GP 1900 (Pre-revised) in Higher Education Department.

Appointees shall report to the Director Colleges, J&K Jammu within a period of 21 days from the date of issuance of this order. They shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Certificate from General Manager. DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

The appointment of the candidates shall be governed by the J&K Special Recruitment Rules, 2015, notified vide SRO 202 of 2015 dated 30-06-2015.

The appointment of candidates shall however, be on probation for a period of five (05) years. During the period he/she shall be entitled to draw pay+grade pay without any other allowances in terms of J&K Special Recruitment Rules, 2015) notified vide SRO 202 of 2015 dated 30-06-2015 and shall be entitled for fixation of pay in the time scale of pay applicable to the post after completion of 05 years of satisfactory.

The appointment shall be subject to the following conditions.

- a) The appointees shall give an undertaking duly attested by a judicial Magistrate, to the effect that in case adverse report about their character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, their appointment shall be deemed to be cancelled ab-initio and they shall have no claim on their appointment.
- b) The verification of qualification/ reserved category certificate (Wherever applicable) from the concerned quarters/issuing received.
- c) Salary of the appointees shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.
- d) Further, if on verification, at any time, the certificates produced by the appointees prove fake or forged, the appointment shall be treated as cancelled ab-initio.
- e) The appointment of above candidates shall, however, be subject to outcome of writ petition, if any pending in any court of law.
