Subject: Cancellation of appointment order of Mr Zahid Nawaz S/o Manzoor Ahmad Bhat C/o Dr Manzoor Ahmad Bhat Khwaza Bagh Colony, Zakura for the post of Assistant Professor (Biotechnology) under OM category in Higher Education Department.

Whereas, **Higher Education department referred 10 posts (OM=7, RBA=1, SC=1 & ST=1)** of Assistant Professor in the discipline of Bio-Technology vide No. HE-Coll/Coord/Apptt/AP/2017 Dated: 18-10-2017 to Jammu and Kashmir Public Service Commission for selection of suitable candidates, in terms of Jammu and Kashmir Education (Gazetted) College Service Recruitment Rules of 2008, amended and notified vide SRO 124 of 2014 dated: 21-04-2021.

Whereas, JKPSC recommended the appointment of 09 selected candidates as Assistant Professors (Biotechnology) in HED vide letter No. PSC/DR/AP/Biotechnology/Hr.Edu/2019 dated 28-01-2022.

Whereas, Higher Education Department appointed 9 Selected candidates as Assistant Professor Biotechnology in Higher Education Department including **Dr Zahid Nawaz** as Assistant Professor (Biotechnology) in separate order vide GO No. 157 JK-HE of 2022 dated 16.6.2022 and subsequently posted him at GDC, Shopian and is directed to report to the concerned Principal within a period of 21 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled without any notice.

Whereas, he requested to this department through email for grant of extension in joining time as the concerned appointee is pursuing research (post-doctoral fellowship) in abroad.

Whereas, the Department had informed by issuing formal letter on 02.08.2022 to Dr Zahid Nawaz on his email id:nawazzahid@gmail.com that there is no provision of extension of joining and the department is empowered to cancel his appointment order as he has failed to join at GDC Shopian within 21 days.

Whereas, Dr Zahid Nawaz has again requested to this department through email for grant of extension in joining time as he is pursuing research (post-doctoral fellowship) abroad and vide e-mail dated 22nd August 2022, he is requesting for one time exception that he is ready to join the department without fail.

Whereas, department has referred the case to GAD for seeking advice in the instant case. In response, GAD vide U.O GAD-MTGORBIV/212/2022-09-GAD (7016261) Dated: 08-09-2022 returned the file with the remarks that the department is advised to cancel the appointment order of Mr. Zahid Nawaz, Assistant Professor (Biotechnology) appointed vide Government Order No.157-JK(HE) of 2022 dated 16.06.2022, in terms of Circular No.08 JK(GAD) of 2019 Dated: 04.12.2019, read with

Government Order No.1003-JK(GAD) of 2021, dated 27.09.2021. Thereafter, refer the said post accrued due to non-joining to the J&k Public Service Commission, for making fresh selection".

Now, therefore keeping in view of above, the appointment of **Mr Zahid Nawaz S/o Manzoor Ahmad Bhat C/o Dr Manzoor Ahmad Bhat Khwaza Bagh Colony, Zakura** as Assistant Professor (Biotechnology) under OM Category in Higher Education Department is deemed to have been cancelled ab initio.
