Whereas, J&K Public Service Commission vide letter No. PSC/DR/A.P/History/2017 dated 03.07.2019 has recommended Sh. Amir Suhail S/o Sh. Mohammad Mushtaq Wani R/o 01 Bhadrot Saringal, Bhaderwah for appointment as Assistant Professor (History) RBA Category in Higher Education Department; and

Whereas, J&K Higher Education Department vide Government Order No. 55 JK(HE) of 2019 dated 17.12.2019 accepted the recommendation of J&K Public Service Commission and appointed Sh. Amir Suhail as Assistant Professor (History) under RBA category on regular temporary basis, in pay scale of Rs. 15600-39100 with AGP of Rs. 6000/- (Pre-revised) Academic Level 10 with pay structure of Rs.57,700) and with the direction to report to concerned Nodal Principal within a period of 21 days from the date issuance of appointment order failing which the appointment shall be deemed to be cancelled without any notice; and

Whereas, Nodal Principal vide letter No.WCG/2642 dated 08.01.2020 has intimated that Sh. Amir Suhail appointed as Assistant Professor in the subject of History (RBA Category) has not reported to duties till date in the office of concerned Nodal Principal.

Whereas, as per Circular No.08 JK (GAD) of 2019 dated 04.12.2019 under endorsement No.GAD(Ser)Genl/Circ/06/01 dated 04.12.2019 issued by the General Administration Department, it has been provided that **"the candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice"**

Now, therefore, appointment of Sh. Amir Suhail S/o Sh. Mohammad Mushtaq Wani R/o 01 Bhadrot Saringal, Bhaderwah (RBA Category) as Assistant Professor (History) issued vide Government Order No. 55 JK(HE) of 2019 dated 17.12.2019 in Higher Education Department is hereby cancelled;
