**Government Order No:- 81 -JK(HE) of 2021  
Dated:- 05-03-2021**

In terms of Rule 6 of Jammu and Kashmir Civil Services Medical (Attendance-Cum-Allowance) Rules 1990, Sanction is hereby accorded to grant of advance drawal upto 75% of the estimated cost of treatment to be duly authenticated from the hospital where from treatment is to be taken. However, the payment shall be made in the form of demand draft directly to the concerned hospital. This sanction shall be subject to the fulfilment of following conditions:-

1. The terms and conditions as laid down in J&K Medical Attendance Rules of 1990 shall be strictly adhered to.
2. The treatment shall be admissible under rules and reimbursement shall be restricted to the admissible items/procedures for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS, New Delhi.
3. The payment shall be released after fulfilment of all Codal formalities.
4. The Red Account/Adjustment Bill shall be furnished to the Accountant General J&K Jammu in respect of advance within stipulated time.
5. Essentiality certificate on Form-2 issued by the hospital authorities be obtained and kept on record.
6. Dependency of the patient on the officer is established under rules before reimbursement of the claim.
