**Subject:** Accord of Administrative Approval for Construction of Boys Hostel 1 at Islamic University of Science & Technology (IUST) Campus, Awantipora.

In exercise of powers conferred in S.O. 15, dated: 9th of January, 2020 issued under endorsement No. A/PS/DC/2019-62 Dated: 09.01.2020, Administrative Approval is hereby accorded to the Construction of Boys Hostel 1 at Islamic University of Science & Technology Campus, Awantipora at an estimated cost of **Rs 1292.29 lakh (Rupees Twelve Crore Ninety Two Lakh and Twenty Nine Thousand only).**

This Administrative Approval is subject to the following conditions:

1. That the proposals are strictly devised and designed as per the latest relevant I. S Codes & specifications of PWD/CPWD and same is authenticated and proof checked by the competent authority. While designing, latest HFL has to be taken into consideration for flood prone locations and adequate provisions in design need to be incorporated for making the structures resistant to earthquakes.
2. That the Electrical/ Mechanical Components are authenticated and technically vetted by the competent Authorities of relevant field.
3. That the standard specifications are followed as per CPWD, NBC and I. S standards.
4. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE-2020 for the type of structures, proposed in each PPR, are followed and adopted for the execution of the works.
5. That the rates for the items, not covered in JKSSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by competent authority well before invitation of tenders in accordance with set Codal procedures.
6. That the Lump sum provisions, either in terms of percentage or fixed as made for certain components of each PPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by Component Authorities well before invitation of tenders in accordance with set Codal procedures.
7. That **e-tendering mode is followed for fixation of the award of contract for execution of each project and wide publicity of the tender is ensured both through Electronic & Print media.** Fragmentation of project, while e-tendering, is not allowed.
8. That there is no time or cost overrun involved in the project and set time line is strictly adhered to. No escalation shall be admissible under any circumstance.
9. That all the Codal formalities shall be followed as per the provision laid down in GFR-2019 issued by Department of Expenditure, Ministry of Finance, GoI and other instructions/ Orders/ guidelines by J&K Government.
10. That the NOCs from all Regulatory Authorities are sought before the commencement of works.
11. That the Registrar of the University shall apprise the department on monthly basis about the progress of the works once started by the Executing Agency.
12. The proper rate analysis and market survey is conducted in light of standing rules and procedures in case of all the items proposed to be executed on ground prior to issuance of formal NIT, in order to ensure rationality of rates.
13. The copy of NIT floated & subsequently copy of allotment order issued against NIT shall invariably be endorsed to the Administrative Department.
14. Photographic evidence before, during & after completion of project shall also be submitted for record & reference purpose.
15. That the Administrative Approval shall neither be construed as any rate approval nor Technical Sanction to the Project.
