In exercise of powers conferred in S.O. 15, dated: 9th of January, 2020 issued under endorsement No. A/PS/DC/2019-62 Dated: 09.01.2020, Administrative Approval is hereby accorded to the Renovation of College Heritage Buildings at GGM Science College, Jammu at an estimated cost of Rs 587.65 lac (Rupees Five Crore Eighty Seven Lac and Sixty Five Thousand only) as per the following break up:

This Administrative Approval is subject to the following conditions:

1. That the proposals are strictly devised and designed as per the latest relevant I. S Codes & specifications of PWD/CPWD and same is authenticated and proof checked by the competent authority. While designing, latest HFL has to be taken into consideration for flood prone locations and adequate provisions in design need to be incorporated for making the structures resistant to earthquakes.
2. That the standard specifications are followed as per CPWD, NBC and I. S standards.
3. That the rates for the items, not covered in JKSSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by competent authority well before invitation of tenders in accordance with set Codal procedures.
4. That the Lump sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by Component Authorities well before invitation of tenders in accordance with set Codal procedures.
5. That e-tendering mode is followed for fixation of the award of contract for execution of the project and wide publicity of the tender is ensured both through Electronic & Print media. Fragmentation of project, while e-tendering, is not allowed.
6. That there is no time or cost overrun involved in the project and set time line is strictly adhered to. No escalation shall be admissible under any circumstance.
7. That all the Codal formalities shall be followed as per the provision laid down in GFR-2019 issued by Department of Expenditure, Ministry of Finance, GoI and other instructions/ Orders/ guidelines by J&K Government.
8. The copy of NIT floated & subsequently copy of allotment order issued against NIT shall invariably be endorsed to the Administrative Department.
9. Photographic evidence before, during & after completion of project shall also be submitted for record & reference purpose.
10. That the Principal of the College shall apprise the department on monthly basis about the progress of the works once started by the Executing Agency.
11. That the Administrative Approval shall neither be construed as any rate approval nor Technical Sanction to the Project.


