On the recommendations of the J&K Public Service Commission, sanction is hereby accorded to the appointment of **Mr. Rajesh Singh Manhas S/O Ranjit Singh Manhas** under **RBA category** as Assistant Professor (Geology) on regular temporary basis in the pay band of Rs.15600-39100 with AGP Rs.6000/- (Pre-revised) Academic Level-10 with pay structure of Rs. 57700/-) in the Higher Education Department and posted at GDC Udhampur against any available vacancy.
The appointment of candidate shall be subject to the following conditions:-

1. The appointee will be on probation for a period of two years from the date of joining.
2. The appointee shall report to the concerned Principals Jammu/Srinagar within a period of 21 days from the date of issue of this order failing which their appointment shall be deemed to have cancelled without any notice.
3. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
4. The inter-se-seniority of the above candidate shall be issued later on as per their merit.
5. The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal.
 - a. Domicile Certificate.
 - b. Date of Birth Certificate.
 - c. Qualification and Marks Certificates i.e. NET/SLET/Ph.D. etc and marks cards/degrees.
 - d. Category certificate as may be applicable to the appointee.
 - e. A certificate from the Director Employment that the candidates has liquidated loan taken if any.
 - f. Health and Medical Certificate.
 - g. Any other certificate as required under law/eligibility requirements.

The appointment of the candidate shall remain provisional till such time as the certificates are got verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and *void ab initio*.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any, pending before the Court of law.
