In continuation to Govt. Order No. 129-JK(HE) of 2022 dated 18-05-2022 and on the recommendations of the J&K Public Service Commission, sanction is hereby accorded to the appointment of **Zahid Nawaz S/o Manzoor Ahmad Bhat R/o C/o Dr Manzoor Ahmad Bhat, Khwaja Bagh Colony, Zakura** under OM category as Assistant Professors (Biotechnology) in the pay band of Rs. 15600-39100 with AGP of Rs. 6000/- (pre-revised), Academic level-10 with pay structure of Rs. 57700/- in the Higher Education Department and posted at GDC Shopian against an available vacancy.

The appointment of candidate shall be subject to the following conditions:-

1. *The appointee will be on probation for a period of two years from the date of joining.*
2. *The appointee shall report to the concerned Principal within a period of 21 days from the date of issue of this order failing which their appointment shall be deemed to have cancelled without any notice.*
3. *The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.*
4. *The inter-se-seniority of the above candidate shall be issued later on as per their merit*
5. The appointment of the candidate shall be subject to outcome of writ petition(s), if any pending, before any court of law.
6. *The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:*
 - a. Domicile Certificate
 - b. Date of Birth Certificate.
 - c. Qualification and Marks Certificates i.e, NET/SLET/Ph.D. etc and marks cards/degrees.
 - d. Category certificate as may be applicable to the appointee.
 - e. A certificate from the Director Employment that candidates has liquidated loan taken if any.
 - f. Health and Medical Certificate.
 - g. Any other certificate as required under law/eligibility requirements.

In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and void ab initio.


