**Whereas;** the Higher Education department vide Indent No. HE/Coll/COORD/APPTT/AP/2017 dated: 18-10-2017 referred 10 posts [OM:06, RBA:02, ST:01 & ALC:01] of Assistant Professor in the discipline of Home Science, to the Jammu and Kashmir Public Service Commission for selection of suitable candidates.

**Whereas;** JKPSCT vide letter No. **PSC/DR/HE/AP-Home Science/2017 Dated: 18-01-2022** conveyed the recommendation of Commission for appointment of 08 candidates i.e **06** selected candidates under OM category, 01 candidate each under RBA and ST categories. one post each under RBA and ALC category have been remained vacant due to non availability of candidate.

**Whereas;** the Higher Education Department vide Government Order No. 127-JK(HE) of 2022 Dated: 18-05-2022 issued appointment order in respect of **06** candidates under **OM** category. However, the verification report of Character and antecedents in respect of Ryhana Abdullah of **RBA category** is still awaited.

**Whereas;** One candidate viz **Ms. Tashi Dolkar D/o Tundup Angdus R/O Leh (selected candidate under ST category)** submitted an application along with undertaking/affidavit duly attested by Magistrate First class and show her **unwillingness to join** as Assistant Professor. She further added that she is not interested to join the said post and has no objection if next waiting candidate be cleared against the post of AP and that in future, she will not claim the said post.

**In view of above, it is hereby ordered that the candidature as well as claim of Ms. Tashi Dolkar D/o Tundup Angdus R/o Leh (selected candidate under ST category) on the post of Assistant Professor, Home Science is cancelled with immediate effect.**
