Subject:- Cancellation of candidature of Mr. Liaqat Ali S/o Abdul Hafiz R/o Keri P/O Soulki Tehsil Kalakote under ST Category for the post of Assistant Professor (Urdu) in Higher Education Department.

Whereas, J&K Public Service Commission vide J&K PSC letter No PSC/DR/AP/Urdu/Hr. Edu/2017 dated 20-08-2021 recommended the name of Liaqat Ali S/o Abdul Hafiz R/o Keri P/o Soulki The. Kalakote under ST Category along with other 04 selected candidate for appointment as Assistant Professor (Urdu) in pay scale of Rs.15600-39100with AGP of Rs 6000/- .

Whereas, Liaqat Ali has submitted his consent to the department for withdrawal of his candidature for the post of Assistant Professor Urdu vide letter dated 30-09-2021.

Whereas, Higher Education Department vide Government Order No. 87-JK(HE) of 2022 dated 18-04-2022, issued appointment order in respect of 04 selected candidates (except Liaqat Ali), who had submitted their verification rolls for CID Verification and after receiving satisfactory verification report from the Special Director General of Police, CID. But Liaqat Ali has not submitted his verification rolls for CID Verification..

Whereas, Mr. Liaqat Ali through medium of Department's letter vide No. HED-estb/198/2021-04 dated 02-05-2022 again has been given final opportunity to submit his Character and Antecedent Roll for CID verification but he failed to submit in time.

Now, therefore, keeping in view of above facts, candidature of **Mr. Liaqat Ali S/o Abdul Hafiz R/o Keri P/o Soulki Tehsil Kalakote under ST Category for the post of Assistant Professor(Urdu)** in Higher Education Department is hereby cancelled ab-initio.
