Government Order No: 99 -JK (HE) of 2023 Dated: 20 -04-2023

Sanction is hereby accorded to the constitution of "Executive Committee" under Jammu and Kashmir Higher Education Council (JKHEC) with the following composition:-

Chairperson:-

Vice Chairman, Jammu and Kashmir Higher Education Council.

Members:

- 1. Principal Secretary to Government, Higher Education Department.
- 2. Vice Chancellors of all Universities, UT of J&K.
- 3. Special Secretary/ Additional Secretary to Government, Higher Education Department.
- Director Colleges, J&K (Member Secretary).
- 5. Principals (Members of JKHEC).

Roles & Responsibilities: -

- Executive Committee shall render all the necessary assistance to Jammu and i. Kashmir Higher Education Council on formulation of policy for a comprehensive and holistic, transformation of Higher Education Sector in tune with NEP 2020.
- Executive Committee shall furnish necessary advise to the Jammu and Kashmir ii. Higher Education Council for formulation and implementation of policies, strategize and steer expansion of the Higher Education Institutions.
- The committee shall provide necessary assistance to the Jammu and Kashmir iii. Higher Education Council for making improvements in curriculum and syllabi including advise on introduction of new courses in accordance with changing industrial requirement, review periodically the Statutes, academic and ordinances and regulations of the Universities of the UT. The committee also suggests appropriate changes for the realization of the objectives of NEP-2020 and to promote framework for institutional accountability through a proper regulatory system.
- The Committee shall assist and advise Jammu and Kashmir Higher Education iv. Council in improvising the standards of examination suggest reforms, devise mechanism for social audit process and public feedback on performance and achievements.

Vec K

- v. The executive committee shall responsible for rendering all the ministerial assistance for convening the meeting of Jammu and Kashmir Higher Education Council.
- vi. Member Secretary of the Executive Committee shall be responsible for placement of agenda before the Jammu and Kashmir Higher Education Council through Executive Committee for its approval.
- vii. Meeting of the Executive Committee shall be called by the Chairperson of the committee and the committee shall at least meet on quarterly basis to review and monitor the implementation of decision taken in Jammu and Kashmir Higher Education Council.
- viii. The power to appoint or remove any members of executive committee or to amend or alter the terms and reference of the executive committee shall vest with the Jammu and Kashmir Higher Education Council.
- ix. The term of the Executive Committee shall be for a period of two years or coterminus with the Jammu and Kashmir Higher Education Council, whichever is earlier.
