- 4. Permanent Resident Certificate.
- Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment shall be subject to the following condition.

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about her character and antecedents is received from the Inspector General of Police CID, Jammu and Kashmir to whom a reference shall be made by the department, her appointment shall be deemed to be cancelled ab-initio and she shall has no claim on her appointment.
- b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.

The appointment of above candidate shall, however, be subject to outcome of writ petition if any pending in any court of law.

The candidate shall be on probation for a period of two years from the date of joining into Government service and the seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board.
