Subject: Termination of appointment of Sh. Shivinder Singh, Sh. Varinder Kumar and Sh. Raja Nisar Ali, as Assistant Professors (Physics) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No.PSC/DR/Asstt. Prof./Physics dated 08-07-2016 recommended Sh. Shivinder Singh S/o P.S. Thakur R/o H. No.81, Suranksha Vihar Phase III, Paloura, Top, Jammu, Sh. Varinder Kumar S/o Sandokh Ram, R/o Village Kashrh Channi Morah, Opp. Gas Agency Dhar Road, P.O. Kawa and Sh. Raja Nisar Ali S/o Ali Mohammad Bhat, R/o Riyazat Tang, Khanyar, Srinagar; for appointment to the post of Assistant Professors (Physics) in Higher Education Department;: and

Whereas, the Department accepted recommendations of J&K Public Service Commission and issued appointment orders in favour of above mentioned selectees as Assistant Professors in Physics on regular temporary basis in pay scale of Rs.15600-39100 with AGP of Rs.6000 vide Govt. Order No.267-HE of 2016 dated 16-08-2016 and posted them in GDC, Akhnoor, GDC, Ganderbal and GDC, Kathua respectively; and

Whereas, the appointees were directed to join their services within a period of 21 days from the date of issuance of appointment order, failing which their appointment will be deemed to have been cancelled; and

Whereas, Principal, GDC, Akhnoor, GDC, Ganderbal and GDC, Kathua reported that Sh. Shivinder Singh, Sh. Varinder Kumar and Sh. Raja Nisar Ali have not joined in their respective Colleges within the stipulated time; and.

Whereas, this Department served a Notice to Sh. Shivinder Singh, Sh. Varinder Kumar and Sh. Raja Nisa Ali, directing them to report to concerned Principals within a period of 15 days from the date of reception/publication of Notice in leading

news papers, failing which their appointment shall be deemed to have been cancelled; and

Whereas, the Principal GDC, Akhnoor, GDC, Ganderbal and GDC, Kathua have again reported that Sh. Shivinder Singh, Sh. Varinder Kumar and Sh. Raja Nisa Ali have not joined their services even after publication of Notice in leading news papers; and posts are lying vacant, thereby adversely impacting the academics in their respective Colleges.

Now, therefore, it is hereby ordered that appointments of Sh. Shivinder Singh, Sh. Varinder Kumar and Sh. Raja Nisa Ali as Assistant Professors (Physics) in Higher Education Department are cancelled and they are discharged from Govt. services in terms of clause (C) of Govt. Order No.267-HE of 2016 dated 16-08-2016.
