Subject: Cancellation of appointment of Assistant Professors (Computer Application) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No.PSC/DR/AP/Comp. App/113-14 dated 25-11-2016 recommended following candidates for appointment as Assistant Professors (Computer Application) in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.371-HE of 2016 dated 13-12-2016 accepted recommendations of J&K, Public Service Commission and appointed above mentioned candidates as Assistant Professors (Computer Application) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/-; and

Whereas, Administrative Department had directed the said appointees to join their services within 21 days from the date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, vide Government Order No.39-HE of 2017 dated 20-0-2017, above said Assistant Professors were posted at A.S. College, Srinagar, Govt. Degree College, Pattan, Govt. College for Women, Baramulla and Govt. Degree College for Boys, Anantnag, respectively; and

Whereas, Nodal Principal, A.S. College, Srinagar vide his letter dated 24-01-2017 has intimated that above mentioned Assistant Professors (Computer Application) have not joined their services within stipulated time period and as such the posts are lying vacant; and

Whereas, this Department served a Notice vide No.HE-Coll/Appt/AP/Com. Appl. P.F. dated 03-03-2017 to above said appointees with the directions to join their respective places of postings with a period of seven days from the date of receipt of Notice or its publication in local daily, whichever happens earlier, failing which their appointment shall be deemed to have been cancelled without any further notice. The notice was also circulated in local Newspapers as well as uploaded to departmental website; and

Whereas, Nodal Principal, A.S. Colleges, Srinagar has again informed that above mentioned Assistant Professors have not joined their services even after sufficient opportunity was granted by Administrative Department.

Now, therefore, appointment of Mr. Abid Hussain Wani S/o Ali Mohd, Wani R/o Lal Bazar Near Play Ground, Srinagar , Mr. Mudasir Mohd S/o Gulam Mohd Dar R/o Sathu Baghwanpora Barbarshah, Srinagar, Mr. Mohsi Altaf Wani S/o Mohd Altaf Wani R/o H.No.15, Mominabad Hyderpora, Byepass Near Asif Filling Station, Srinagar, and Mr. Phuntsog Wangial S/o Nema Chowang R/o Chemday Khalatsepa, Block Kharu, Leh Ladakh, as Assistant Professors (Computer Applications) in Higher Education Department is hereby cancelled.
