Subject: Cancellation of appointment of Sh. Mudasir Ahmad Tantray as Assistant Professor (Philosophy) and appointment of Dr. Yogesh Kumar as Assistant Professor (Philosophy) in Higher Education Department and

Whereas, J&K Public Service Commission vide letter No.PSC/DR/AP/Philosophy/13-14 dated 08-12-2016 recommended 08 candidates under (OM=04, RBA=02, SC=01 & ST=01) for appointment to the posts of Assistant Professors (Philosophy) in Higher Education Department and accordingly appointment orders were issued by this department vide Govt. Order No.384-HE of 2016 dated 23-12-2016; and

Whereas, the appointees were posted by this department in various Government Degree Colleges of State vide Govt. Order No.77-HE of 2017 dated 06-02-2017; and

Whereas, Higher Education Department received a communication bearing No.PSC/DR/AP/Philosophy/13-14 dated 23-02-2017 from J&K, Public Service Commission, Jammu, whereunder, it has been informed that the Commission received an RTI application from one Dr. Yogesh Kumar who was interviewed among other candidates for the post of Assistant Professor (Philosophy), under the O.M. Category, seeking breakup of his total merit points of 60.89. During this process of providing information to the applicant, the Commission observed that it has inadvertently not awarded the 02 points of NCC (C certificate) to the applicant while calculating his overall points. Previous merit of the candidate was 60.89 and after adding 02 points of NCC (C Certificate), his overall merit comes to 62.89 and as such should have figured in the selection zone at S. No.4 in place of already recommended candidate Sh. Mudasir Ahmad Tantray who has secured 61.39 points; and

Whereas, Public Service Commission has now withdrawn recommendations in favour of Sh. Mudasir Ahmad Tantray S/o Gh. Mohiuddin Tantray R/o Haji Mohalla Gund Brath, Baramulla and has recommended Mr. Yogesh Kumar S/o Tara Chand R/o Mohalla Delhara Village & Post Office Khanetar Tehsil Haveli District Poonch for appointment to the post of Assistant Professor (Philosophy) in Higher Education Department. However, Mudasir Ahmad Tantray shall figure at S. No1 in the wait list.

Now, therefore, in view of the above given facts and recommendations furnished by J&K, Public Service Commission, Jammu;

- I. sanction is hereby accorded to the cancellation of appointment of Sh. Mudasir Ahmad Tantray S/o Gh. Mohiuddin Tantray R/o Haji Mohalla Gund Brath, Baramulla, presently posted as Assistant Professor (Philosophy) Govt. College for Women, Baramulla.
- II. sanction is hereby accorded to the appointment of Mr. Yogesh Kumar S/o Tara Chand R/o Mohalla Delhara Village & Post Office Khanetar Tehsil Haveli District Poonch as Assistant Professor (Philosophy) in Higher Education Department on regular temporary basis in the pay

scale of Rs.15600-39100 with AGP of Rs.6000/-. He is posted in Govt. College for Women, Parade, Jammu. His appointment shall be subject to following conditions:

- a) that the appointee shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing him to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he/she taken.
- b) that the appointee will be on probation for a period of two years.
- c) that he will report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment will be deemed to have been cancelled without any notice.
- d) that his salary will be drawn only after a satisfactory report about his character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment will be deemed cancelled without any notice.
- e) that his appointment will also be subject to the outcome of the writ petitions if any pending in the Hon'ble High Court of J&K.




