On the recommendations of the J&K Public Service Commission, sanction is hereby accorded to the appointment of **Miss Priyanka Kumari D/o Vijay Kumar R/o VPO Kalsian, Nowshera** as Assistant Professor (Hindi) on regular temporary basis, in the pay scale of Rs. 15600-39,100 with AGP of Rs. 6000/- (Pre-revised, Academic Level 10 with pay structure of Rs. 57,700/-) in the Higher Education Department and posted in the **Government Degree College Kalakote**.

The appointee shall report to the concerned Principal within a period of 21 days from the date of issue of this order failing which her appointment shall be deemed to have been cancelled without any notice.

The appointment of the candidates shall be subject to the following conditions:-

- a. The appointee will be on probation for a period of two years from the date of joining.
- b. The appointment of the candidate will be subject to verification of satisfactory character and antecedent by the CID.
- c. Her salary shall not be drawn till satisfactory character and antecedent report is received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.
- d. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the Concerned Principal.

- I. Permanent Residential Certificate/Domicile.
- II. Date of Birth Certificate.
- III. Qualification Certificates i.e. NET/SLET/Ph.D.
- IV. Category certificate as may be applicable to the appointee.
