The appointees shall report to the concerned Principal within a period of 21 days from the date of issue of this order.

The candidates who fail to join within a period of 21 (twenty one) days from the date of issue of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

The appointment of the candidates shall be subject to the following conditions:-

- a. The appointee will be on probation for a period of two years from the date of joining.
- b. The appointment of the candidate will be subject to verification of satisfactory character and antecedent by the CID.
- c. Their salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.

- e. The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:

 - ii. Date of Birth Certificate.
 - iii. Academic Qualification Certificates.
 - iv. Additional Qualification Certificate i.e. NET/SLET/Ph.D.
 - v. Category certificate as may be applicable to the appointee.
 - vi. Health Certificate issued by the competent authority.
 - vii. A certificate from the Director Employment that the candidates has liquidated loan taken if any.

The inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any pending, before any court of law.
