- v. That the visit of the Faculty Member will be purely private and shall not be clubbed with any official/semi official activity.
- vi. That the Faculty Member shall not avail any financial support or hospitality from any Govt./Semi Government or professional body.
- vii. That the DDO concerned shall make entries regarding availing of the kind of Leave for the aforesaid period and Foreign Visit in the Service Book of the Faculty Member.
- viii. That she shall not involve herself in any anti-national or subversive activities there.
- ix. That she shall abide the J&K Civil Services (CC&A) Rules, 1956.
