c) Any residency requirements shall be met by taking leave as due and

after getting the same duly sanctioned.

d) The selected faculty members shall undertake, through a legally binding undertaking that they shall serve the department for at least five years after completion of the Ph.D program.

e) Pursuit of Ph.D shall not be considered as a ground for retention of

faculty in a particular location/college.

f) The order shall become operational only after fulfillment of the conditions imposed at (b) & (e) above.
