Subject:- Deputation of Teaching faculty of ICSC Sgr. to other colleges of Valley.

Govt. Order No:3*v*-JK(HE) of 2021 Dated: 3*v*-01-2021.

Whereas, in the meeting of *Islamia College of Science and Commerce, Srinagar* Governing Board held on 08-10-2013, the following decision was taken with regard to deputation of 20% teaching and non teaching faculty members to other colleges of valley:-

"The Ex-Officio Secretary, Islamia College, Principal requested the Board that with a view to bring efficiency in the academic and administrative atmosphere of the College, 20% of the existing teaching and non-teaching faculty members may be considered for deputation to other Valley colleges and Vice-versa. The suggestion was agreed by the Board. However, the staff Representative sought attention of the Board towards the fact that if employees of the Islamia College are deputed to other Colleges, then due care be taken with regard to their seniority. In this regard, the chairman directed the Administrative Secretary, Higher Education Department to take due care while deputing the staff to other colleges. The Administrative Secretary assured that proper mechanism will be evolved in this regard. "
