In continuation to Govt. Order No.309-JK(HE) of 2021 dated 22-10-2021, Govt. Order No.311-JK(HE) of 2021 dated 23-10-2021 and Govt. Order No.312-JK(HE) of 2021 dated 24-10-2021 sanction is hereby accorded to the appointment of selected candidates as Class-IV against the available posts on regular/temporary basis, in the pay scale of Rs. 4440-7440+1300 (pre-revised) with pay structure of Rs.14800-47100 (SL-1) as per Annexure-"A" in the Higher Education Department.

The Appointees shall report to Director Colleges, J&K, Higher Education Department within a period of 21 days from date of issuance of this order for further posting against available post/designation and shall be allowed to join only on production of following documents:-

- 1. Academic / technical qualification certificates.
- 2. Date of Birth certificate.
- 3. Health certificate issued by the competent authority.
- 4. Domicile certificate.
- 5. Certificate from general Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.
- 6. Any other relevant documents, if required.

The Appointment shall be subject to following terms & conditions:-

- Appointee shall give an undertaking duly attested by a Judicial Magistrate a) to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, CID, UT of J&K, his/her appointment shall deem to be cancelled ab-initio and he/she shall have no claim on his/her appointment.
- Salary of the appointee shall not be drawn and disbursed, unless a b) satisfactory report with respect to point (a) above is received.



c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009

d) The appointee shall initially be on probation for a period of two years. Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, appointment shall be treated as cancelled ab-initio.

e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of his/her appointment order, he/she shall forgo his/her right to appointment which shall deem to be cancelled ab-initio without any further notice.

f) The appointment shall be cancelled ab-intio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall be liable for criminal prosecution.

The inter-se-seniority of the appointee shall be issued in accordance with the merit secured by the appointee in the selection list prepared by the J&K SSB.

The appointment of the candidate shall be subject to outcome of writ petition(s), pending in any Competent Court/Tribunal etc.
