Whereas, Mr. Gulzar Ahmad was appointed as Teacher in the School Education Department on 3.4.1989 and subsequently was elevated/promoted to the post of Lecturer and Sr. Lecturer on 12.8.2003 and 25.02.2011 respectively and was posted at Government Higher Secondary School Nishat Srinagar as Senior Lecturer; and

Whereas, vide Government Order No. 332-HE of 2017 dated 8.6.2017, issued by the Higher Education Department, the said officer was deputed to the Cluster University Srinagar against the post of Assistant Registrar after NOC conveyed by the School Education Departments vide their OM No. Edu/V/59/2017 dated 06.06.2017; and

Whereas, the officer has approached this department for his permanent absorption in the Higher Education Department;- and

Whereas, the case was examined in the department and referred to School Education Department for their views/comments with respect to the permanent absorption of the officer; and

Whereas, the School Education Department vide their OM No. Edu/V/59/2017 dated 25.10.201, has conveyed No Objection, subject to the condition that his lien/seniority/promotional prospects from School Education Department shall be deemed to have been terminated from the date of his absorption in Higher Education Department; and

Whereas, the case was again examined in the department and referred to the General Administration Department for their concurrence to the permanent absorption of the officer in the Cluster University Srinagar as Assistant Registrar; and

Whereas, the General Administration Department vide their U.O. NO. GADAdm)299/2017-V dated 16.03.2018 has concurred as under;-

" The Higher Education Department is conveyed the approval of competent authority for permanent absorption of Mr. Gulzar Ahmed, Sr. Lecturer (Botany), Government Higher Secondary School Nishat, Srinagar in the Cluster University, Srinagar against the post of Assistant Registrar subject to the conditions laid down in the Article 185-D (v) and Article 37-G (a) & (c) for the J&K Civil Service Regulations. The official shall be placed at the bottom of the seniority of the respective category prospectively".

Whereas, the General Administration Department has given their concurrence with regard to the permanent absorption of the officer as Sr. Lecturer (Botany) Government Higher Secondary School Nishat Srinagar in the Cluster University, Srinagar against the post of Assistant Registrar; and

Now, therefore, sanction is hereby accorded to the permanent absorption of Mr. Gulzar Ahmad, Sr. Lecturer (Botany) Govt. Higher Secondary School Nishat, Srinagar in the Cluster University, Srinagar against the post of Assistant Registrar subject to the conditions laid down in the Article 185-D (v) and Article 37-G (a) & (c) of the J&K Civil Service Regulations w.e.f. 08.06.2017. The official shall be placed at the bottom of the seniority of the respective category prospectively.


