Formulation of policy regarding permission for pursuing part-time research work by the College faculty members

Government Order No. 4/6 - JK (HE) of 2020 Dated:- 09 -12-2020

In supersession of all previous orders issued on the subject, sanction is hereby accorded to the notification of policy regarding permission for pursuing part time research work by the College faculty members of Higher Education Department as per the following terms and conditions:-

- 1. No Assistant Professors/Associate Professors shall engage in part time research without the permission of the Administrative Department.
- 2. Senior faculty members shall be given preference to junior faculty members in each subject for engaging in part time research.
- 3. Assistant Professors/Associate Professors shall register him/her self for Ph.D within one year from the date of issuance of permission and shall submit the PhD thesis within 5 years from the date of registration. The permission shall be valid for a period of 05 years only.
- 4. Only 10% of Assistant Professors/Associate Professors in a subject shall be allowed to register for Part time research in a year outside the state/UT.
- 5. Only 05 candidates shall be permitted to register in one particular subject in a private University outside the State/UT in a academic year, preference shall be given to the applicant seeking permission to register for Ph.D in Centre/State/UT institutes of research/Universities according to NIRF and NAAC ranking.
 - The Assistant Professors/Associate Professors who are allowed to register for part time research shall carry on research work outside the working hours of colleges and on holidays as well as during vacations. Extra Ordinary leave (without pay leave whatever kind due to him/her shall be allowed as per requirements of the research due to him/her in terms of the statutes of concerned University (upto a maximum of 6 months only). The candidate shall furnish tentative leave schedule while applying for study leave.
- 7. Part time research in Science shall be allowed only in favour of Assistant Professor Associate Professors, in cases whose supervisors of such researchers certify that they can carry on experimental work/ field studies at their places of posting.

Director Colleges shall issue a notification every year on 1st March seeking applications from teachers wishing to pursue Ph.D and recommend cases to the Administrative Department strictly in terms of Clause 04 and 05 of this Government Order alongwith requisite documents and consent letter of the concerned University.

- 9. The Principals of the concerned colleges should certify that the teaching work in the relevant subject will not suffer in case the teacher registered for part time research and is consistent with UGC norms.
- 10. The Assistant Professors/Associate Professors shall serve in the Department for at least 05 years after completing the Ph.D. programme and

All the Ph.Ds obtained should be in consistent with UGC MSP 2016, as admissible from time to time.
