Subject:- Conduct of inquiry against Shri Ghulam Rasool Wani, the then Principal Government Degree College for Women, Ananthag.

Whereas, the Anti Corruption Bureau, Vide No. ACB/very ABP-41/2016/9616-18 dated 01.08.2019, recommended to initiate regular departmental action against Shri Ghulam Rasool Wani, the then Principal Government Degree College Women, Anantnag for recovery of Rs. 40,000/ and for retention of Government money for one year without any justification

Whereas the department also issued the Article of charges and statement of Imputation of conduct in support of Article of Charges against the officer who remained posted in Government Degree College for Women, Anantnag. However, the officer submitted that he has never intentionally either undermined the honour of the chair or misused the power and has realized that an error has occurred; and

Whereas, vide Government Order No. 258 JK (HE) of 2020 dated 10.06.2020, Shri Yaseen Ahmed Shah the then Director Colleges was appointed as Inquiry officer with mandate to investigate the allegations in terms of Jammu and Kashmir (Civil, Services, Classification & Appeal) Rules, 1956 and furnish findings/recommendations within stipulated time: and

Whereas, Inquiry Officer has submitted the enquiry report with recommendations that the officer has deposited the whole amount of Rs 88,000/- involved in two incidents and has recompensed the Government exchequer of the financial losses, it can be assumed that the retiree Shri Ghulam Rasool Wani. Ex-Principal Government Degree College for Women, Anantnag is apologetic and repentant about the whole incident, hence the department may take a lenient view and exonerate the retired Principal; and

Whereas, the recommendations submitted by the Inquiry Officer has been examined and accepted by the competent authority.

Consequent upon the acceptance of the inquiry report by the Competent Authority it is therefore ordered as under:-

- i. Shri Ghulam Rasool Wani, the then Principal Government Degree College for Women, Anantnag is hereby exonerated from charges levelled against him.
- ii. Director Colleges J&K shall submit pension case of Shri Ghulam Rasool Wani, Ex- Principal, Government Degree College for Women Anantnag to AG Office Srinagar for authorisation of his pensionary benefits.
