Appointee shall report to Principal, Govt. College of Engineering & Technology, Jammu within a period of 21 days from the date of issuance of this He shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters:-

- Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- Health Certificate issued by the Competent Authority.
- Permanent Resident Certificate.
- 5. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment shall be subject to the following condition.

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police CID, Jammu and Kashmir to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and he shall has no claim on his appointment.

b) The verification of qualification/ reserved category certificate (wherever

applicable) from the concerned quarters/issuing received.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled abinitio.

The appointment of above candidate shall, however, be subject to outcome of writ petition if any pending in any court of law.

The candidate shall be on probation for a period of two years from the date of joining into Government service and the seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board.
