The salary of the appointees shall be drawn and disbursed after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and subject to production of an affidavit (as per Annexure A) to this order.

The seniority of the candidates shall be determined in term of J&K Civil Services (Classification, control & Appeal) Rules, 1956.

The appointment of the candidates shall remain provisional till time as the certificates get verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and void ab-initio.
