The candidates who fail to join within 21 (twenty one) days from the date of their appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

The appointment of candidates shall be subject to the following conditions:-

- The appointees will be on probation for a period of two years from the date of joining.
- The appointment of the candidates will be subject to verification of satisfactory character and antecedent by the CID.

- c) Their salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.
- d) The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24-12-2009.
- e) The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:-
 - i) Domicile certificate.
 - ii) Date of Birth certificate.
 - iii) Academic Qualification Certificates.
 - iv) Additional Qualification Certificates i.e. NET/SLET/SET/Ph.D
 - v) Category certificate as may be applicable to the appointee.
 - vi) Health certificate issued from the competent authority.
 - vii) A certificate from the Director Employment that the candidates has liquidated loan taken if any.

The inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any pending, before the Court of law.
