Sanction is hereby accorded:

1. to the release of grant-in-aid to the tune of Rs. **490.25** lacs (Rupees Four crores ninety lakhs twenty five thousand) only in favour of the Registrar, Baba Ghulam Shah Badshah University, Rajouri for the year 2020-21.
2. to the release of the said amount in favour of the Director Finance, Higher Education Department for further placement at the disposal of the Registrar, Baba Ghulam Shah Badshah University, Rajouri.

The Grant-in-aid so released shall be subject to the following conditions:

- a) The accounts of the university shall be open to check by the Principal Accountant General, J&K Jammu/Finance Department and the officers of the Higher Education Department at any time.
- b) The University shall furnish the Utilization Certificate to the Accountant General along with a copy to Administrative Department.
- c) The amount so released shall strictly be utilized on the object heads for which same stands released.
- d) No diversion from one head to another head is allowed without the approval of Competent Authority
- e) All Codal formalities/ Procedures shall be adopted strictly
