Subject: Authorization for recognition of teaching staff of Higher Education Department for Cluster University Jammu/Srinagar.

Whereas, the issue of appointment of faculty by way of recognition of teaching staff of the Higher Education Department, as provided in the Act, was discussed threadbare during the meeting co-chaired by Advisor (G) and Advisor (S) and attended by Vice Chancellors of both the Cluster Universities. In the meeting, it was agreed that Cluster University shall have permanent faculty positions to be sanctioned by the Higher Education Department in a Phased manner. The VCs of both the Cluster Universities shall come up with the proposal for various positions to the extent of 50% of the overall sanctioned strength of the Constituent Colleges for appointment by recognition as provided under Section 34 (1)(B) of the Act.

Whereas, both the Cluster Universities came up with their respective proposals, which have been examined in the department keeping in view the objectives of these Universities as provided Under Section 4 of the Srinagar and Jammu Cluster Universities Act, 2016, which lays special emphasis on skill development and creation of skill force, by undertaking industry oriented teaching, outcome based research, extension programmes, promoting innovation in teaching learning process and interdisciplinary research.

Whereas, the Cluster Universities are intended and created with the motive to embark upon curriculum, administration and examination reforms and to have focus on skill courses for industry ready force, which would require starting courses on applied science and also digital technologies which are driving industry 4.0 revolution, for employability and relevance of academic courses. Also Cluster has to focus on outcome oriented research based programmes for societal issues and economic opportunities for larger

gain of the society and inculcating spirit of dignity of labour in students to emerge as agents of social change and economic growth.

Whereas the Cluster Universities shall evolve administrative and academic interventions for PG and UG programmes intended to enhance the spirit of reason & inquiry for development of scientific temper and experiential learning in students and faculty and to establish innovation ecosystem in the institutions of Higher learning

Whereas both the Cluster Universities shall have to firm up admission policy and also the deliverables in the constituent colleges to achieve top score in NAAC, SGPA/CGPA in a time bound framework to achieve excellence in education in respective constituent colleges.

Now, therefore approval of the Competent Authority is accorded in favour of the Constituent Colleges of the Cluster Universities of Jammu and Kashmir for appointing teachers by recognition as per Section 34(1) (B) of the Srinagar and Jammu Cluster Universities Act, 2016 from amongst the faculty members of J&K Gazetted service against the teaching posts allocated to the constituent colleges of the respective universities as per Annexure-A.

The respective Cluster Universities with the approval of the Administrative Department shall adopt regulations governing conditions of service in respect of the appointees in terms of Section 34(1) B well before advertisement and finalizing the selection process. Cluster Universities shall have the academic programmes (PG, IG and UG) under the administrative and academic control of their respective Vice Chancellors through Principals of the respective constituent colleges.
