In exercise of powers conferred in S.O. 15, dated: 9th of January, 2020 issued under endorsement No. A/PS/DC/2019-62 Dated: 09.01.2020, Administrative Approval is hereby accorded to the Construction of Lecture/ Examination Block at Islamia College of Science & Commerce, Srinagar at an estimated cost of Rs 507.68 lac (Rupees Five Crore Seven Lac and Sixty Eight Thousand only).

This Administrative Approval is subject to the following conditions:

- 1. That the proposal is strictly devised and designed as per the latest relevant Code of BIS/ CPWD Manual/ Specifications with special emphasis on earthquake resistance of structure
- 2. That any such item(s) not covered under relevant schedule of rates shall be paid in accordance with the set Codal Procedure.
- 3. That the structural design of the project is got authenticated by competent authority well before the execution of work and same shall account for latest HFL.
- 4. That there is no time or cost overrun involved in the project and set time line is strictly adhered to.
- 5. That the NOC from Regulatory Authority/ PCB may also be sought before the commencement of work.
- 6. That the Electrical Components are authenticated by the Competent Authority before the execution of work takes place.
- 7. That Site Plan/ Building plans and General Abstract of Cost are authenticated by the Project Authority before the commencement of work.
- 8. The stipulation as prescribed for Energy efficient/ rain water harvesting/ green building may be adhered to.
- 9. That the Lump sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by Component Authorities well before invitation of tenders in accordance with set Codal procedures.
- 10. That e-tendering mode is followed for fixation of the award of contract for execution of the project and wide publicity of the tender is ensured both through Electronic & Print media. Fragmentation of project, while e-tendering is not allowed.
- 11. That all the Codal formalities shall be followed as per the provision laid down in GFR-2019 issued by Department of Expenditure, Ministry of Finance, GoI and other instructions/ Orders/ guidelines by J&K Government.
- 12. The copy of NIT floated & subsequently copy of allotment order issued against NIT shall invariably be endorsed to the Administrative Department.
- 13. Photographic evidence before, during & after completion of project shall also be submitted for record & reference purpose.
- 14. That the Principal shall get the instant work approved from Governing Board of the College.
- 15. That the Administrative Approval shall neither be construed as any rate approval nor Technical Sanction to the Project.
