Whereas, as per Circular No.08 JK (GAD) of 2019 dated 04.12.2019 under endorsement No.GAD(Ser)Genl/Circ/06/01 dated 04.12.2019 issued by the General Administration Department, it has been provided that "the candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice"

Now, therefore, appointment of Sh. Amir Suhail S/o Sh. Mohammad Mushtaq Wani R/o 01 Bhadrot Sartingal, Bhaderwah (RBA Category) as Assistant Professor (History) issued vide Government Order No. 55 JK(HE) of 2019 dated 17.12.2019 in Higher Education Department is hereby cancelled;
