The appointee shall report to the Administrative Department within a period of 21 days from the issue of this order.

The candidate who fail to join within 21 (twenty one) days from the date of their appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab initio without any further notice.

The appointment of candidate shall be subject to the following conditions:-

- The appointee will be on probation for a period of two years from the date of joining.
- The appointee shall report to the Administrative Department within a period of 21 days from the date of issue of this order failing which their appointment shall be deemed to have cancelled without any notice.
- The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- The inter-se-seniority of the above candidate shall be issued later on as per their merit.
- The appointment of the candidate shall be subject to outcome of writ petition(s), if any pending, before any court of law.
- The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal.
 - a. Domicile Certificate.

- b. Date of Birth Certificate.
- c. Qualification and Marks Certificates i.e. NET/SLET/Ph.D. etc and marks cards/degrees.

d. Category certificate as may be applicable to the appointee.

- e. A certificate from the Director Employment that the candidates has liquidated loan taken if any.
- f. Health and Medical Certificate.
- g. Any other certificate as required under law/eligibility requirements.

The appointment of the candidate shall remain provisional till such time as the certificates are got verified by the Administrative Department and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and void ab-initio.
