 - c) Qualification and Marks Certificate i.e. NET/SLET/Ph.D. etc and Marks Cards/Degrees.
 - d) Category Certificate as may be applicable to the appointees.
 - e) Health and Medical Certificate.
 - f) Any other certificate as required under law.

The salary of the appointees shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and subject to production of an affidavit (as per Annexure-A) to this order.

The inter-se-seniority of the candidates shall be determined in term of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

The appointment of the candidates shall remain provisional till such time their certificates get verified by the concerned Principals and are found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate shall be deemed to have been cancelled ab-initio.

The appointment of the candidates shall be subject to outcome of Writ Petition(s), if any, pending before any Court of Law.
