The appointees shall report to the concerned Principal within a period of 21 days from the issue of this order.

The candidates who fail to join within 21 (twenty one) days from the date of their appointment order shall forego their right to appointment which shall be deemed to have been cancelled *ab initio* without any further notice.

The appointment of candidates shall be subject to the following conditions:-

- a) The appointees will be on probation for a period of two years from the date of joining.
- b) The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- c) The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:
 - i) Domicile certificate.
 - ii) Date of Birth certificate.
 - iii) Academic Qualification Certificates.

- iv) Additional Qualification Certificates i.e. NET/SLET/SET/Ph.D.
- v) Category certificate as may be applicable to the appointee.
- vi) Health certificate issued from the competent authority.
- vii) A certificate from the Director Employment that the candidates has liquidated loan taken if any.

The appointment of the candidate shall remain provisional till such time as the certificates are got verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and void *ab initio*.

The inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any, pending before the Court of law.
