In continuation to Government Order No. 131-JK(HE) of 2024 dated 29.02.2024 and as recommended by the J&K Public Service Commission, sanction is hereby accorded to the appointment of Ms. Hafsa Maqbool Malik D/o Mohmmed Maqbool Malik R/o 60 A Rose Avenue Colony Lane 1 HMT, Srinagar, selected under OM Category as Assistant Professor (Psychology) on regular temporary basis in the pay band of Rs. 15600-39100 with AGP Rs. 6000/- (Pre-revised) Academic Level-10 with pay structure of Rs. 57700/-) in the Higher Education Department notionally w.e.f 29.02.2024 and monetarily with immediate effect.

The appointee shall report to the Nodal Principal, A.S. College, Srinagar within a period of 21 days from the date of issuance of this order failing which her appointment shall be deemed to have cancelled without any notice.

The appointment of candidate shall be subject to the following conditions:-

- 1. The appointee will be on probation for a period of two years from the date of joining.
- 2. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- 3. The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal.
  - a) Domicile Certificate.
  - b) Date of Birth Certificate.
  - Qualification and Marks Certificate i.e. NET/SLET/Ph.D. etc and marks cards/degrees.
  - d) Category certificate as may be applicable to the appointee.
  - e) Health and Medical Certificate.
  - f) Any other certificate as required under law.

The salary of the appointee shall be drawn and disbursed after the receipt of the satisfactory report in respect of the genuineness of Qualification/Date of Birth/ Relevant Category Certificate and subject to production of an Affidavit as per **Annexure-A** to this order.

The inter-se-seniority of the candidate shall be determined in term of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

The appointment of the candidate shall remain provisional till such time as the certificates get verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been cancelled ab-initio.

The appointment of the candidate shall be subject to outcome of Writ Petition(s), if any, pending before the Court(s) of law.
