In continuation to the Government Order No. 51-JK(HE) of 2024dated 29.01.2024 and as recommended by the J&K Public Service Commission, sanction is hereby accorded to the appointment of Ms. Farrukh Rana Mufti D/o Peerzada Mufti Muhammad Yaqub R/o South City Khanday Colony Nowgam Puhur Chowk under O.M Category as Assistant Professor, Biochemistry, on Regular Temporary basis in the Pay Band of Rs.15600-39100 with AGP Rs.6000-(Pre-revised) Academic Level-10 with Pay Structure of Rs.57700- in the Higher Education Department notionally w.e.f 29.01.2024 and monetarily with immediate effect.

The appointee shall report to the Nodal Principal, Government College of Education, Srinagar within a period of 21 days from the date of issuance of this order failing which her appointment shall be deemed to have been cancelled without any notice.

The appointment of the candidate shall be subject to thefollowing conditions:-

1. The appointee will be on probation for a period of two years from the date of joining.

2. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.

- 3. The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:
 - a. Domicile Certificate.
 - b. Date of Birth Certificate.
 - c. Qualification and Marks Certificate i.e. NET/SLET/Ph.D. etc and Marks Cards Degrees.
 - d. Category Certificate as may be applicable to the appointee.

e. Health and Medical Certificate.

f. Any other certificate as required under law.

The salary of the appointee shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and subject to production of an affidavit as per Annexure-A to this order.

The inter-se-seniority of the candidate shall be determined in terms of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

The appointment of the candidate shall remain provisional till such time the certificates are got verified by the concerned Principal and are found to be in order. In case any certificate is found to befake, inadequate or not consistent with the eligibility requirements, the appointment of the candidate shall be deemed to have beencancelled ab-initio.

The appointment of the candidate shall be subject to outcome of Writ Petition(s), if any, pending before any Court of law.
