Appointees shall report to concerned college within a period of 21 days from the date of issuance of this order. They shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters:-

- 1. Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment shall be subject to the following conditions:-

- a) The appointees shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about their character and antecedents is received from the Inspector General of Police CID, Jammu and Kashmir to whom a reference shall be made by the department, their appointment shall be deemed to be cancelled ab-initio and they shall has no claim on his/her appointment.
- b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.

The salary of the appointees shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

Further, if on verification, at any time, the certificates produced by the appointees prove fake or forged, the appointment shall be treated as cancelled ab-initio.

The appointment of above candidates shall, however, be subject to outcome of writ petition, if any pending in any court of law.

The candidates shall be on probation for a period of two years from the date of joining into Government service and the seniority of the appointees shall be maintained as per merit furnished by the Service Selection Board.
