On the recommendations of J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of following candidates as Library Assistant in Higher Education Department in the Pay Level- 2 (19,900-63,200) with immediate effect:-

The appointees shall report to Director Colleges, J&K within 21 days from the date of issuance of this order, and if anyone fails to join within the stipulated time, shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

1. Academic qualification certificates.
2. Matriculation /Date of Birth certificate.
3. Health certificate from the concerned Chief Medical Officer of the District.
4. Domicile certificate issued by the Competent Authority.
5. That, if the candidates have taken loan for self employment from DIC/ Employment Department, to be ascertained from District Industries Centre (DIC) and District Employment and Counseling Center of the domicile district, they shall relinquish the proprietorship of unit/ enterprise and also stakes, if any in such self employment unit/ enterprise before joining the Government Service. They shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO Concerned shall obtain an affidavit from the concerned appointees regarding both relinquishment from proprietorship and stakes, if any in such self employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
6. Valid relevant Category Certificate.
7. Any other relevant documents required under rules.

The Appointment of the above candidate shall further be subject to the following conditions:

- a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory on the appointees to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment adverse System (EVS). Any false information provided by the appointees or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment ab-initio without any further notice.
- b. If, on verification, the qualification certificates/ DOB and other documents from the concerned issuing authority are proved fake/ forged, the claim of the appointees for appointment as (Library Assistant) shall be deemed to have

cancelled ab-initio and the legal action as warranted under rules shall be initiated against them.

- c. The salary of the appointees shall not be drawn and disbursed to them, unless satisfactory reports in respect of genuineness of Qualification /Date of Birth and Relevant Category Certificate and final character and antecedents report is received from the concerned authorities / agencies.
- d. The appointees shall be on probation for a period of two years.
- e. The appointment of the appointees shall be governed by the "New Pension Scheme" as notified SRO 400 of 2009 dated 24-12-2009.
- f. The inter-se-seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g. The appointment of the above appointees shall be subject to outcome of writ petition(s), pending in any Competent Court /Tribunal etc.
- h. In case of any certificate found fake/ incorrect, the appointment of the candidates shall be taken to have been cancelled ab-initio.
- i. The appointees shall furnish an undertaking in the shape of an Affidavit as per Annexure-A to this order.






