On the recommendations of the J&K Services Selection Board, and as approved by the Competent Authority and conveyed by General Administration Department vide U.O. No. GAD- CORD/153/2023-09 dated 10.01.2024, sanction is hereby accorded to the appointment of following candidates as Class-IV (now Multi Tasking Staff) on temporary basis in the Higher Education Department in the Pay Level of SL-1 (14800-47100) notionally w.e.f 29.10.2022 and monetarily from date of joining:

The appointees shall report to Director Colleges within a period of twenty one (21) days from the date of issuance of this order failing which they shall forego their right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
 - Health Certificate from the concerned Chief Medical Officer of the District.
 - Domicile Certificate issued by the Competent Authority.
 - That if the candidates have taken loan for self employment from DIC /Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, they shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. They shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- vi. Valid relevant Category Certificate, if applicable.
- vii. Any other certificate required under rules.

The appointment of the above candidates shall further be subject to the following conditions:

- a) The appointees shall furnish an undertaking in the shape of an Affidavit to the effect that the appointees have no criminal records and also not facing any criminal proceedings in any court of law as per Annexure-A to this order.
- b) If, on verification, qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Class-IV) shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against them.
- c) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agencies.
- d) The appointees shall be on probation for a period of two years.
- e) The appointment of the appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g) The appointment of the above appointees shall be cancelled ab-initio, if it is found that they possess higher qualification than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law.
- h) The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- In case of any certificate found fake/incorrect, the appointment of the candidates shall be taken to have been cancelled ab-initio.
