Whereas, the Higher Education Department accept the recommendation of J&K Services Selection Board and below mentioned candidates appointed as Senior Laboratory Technician, Mechanical Engineering (Divisional cadre Jammu) vide Government Order No. 523-HE of 2017-HE of 2017 dated 07-09-2017;

Whereas, the Principal, Government College of Engineering & Technology, Jammu vide letter No.GCET/2017/SLT/4132 dated 21-10-2017 has informed that below mentioned candidates have not joined the concerned College till date:

Whereas, a notice was served upon the above mentioned candidates (through print media) vide letter No. HE-Coll/NGJ/Apptt-SLT/Mech.Engg/2017 dated 13-12-2017 to report the concerned Colleges where they have been posted within a period of 10 days from the date of publication of the notice, failing which their appointment shall be deemed to have been cancelled without any further notice;

Whereas, the Principal, Govt. College of Engineering & Technology, Jammu vide letter No. GCET/2017/SLT/4532 dated 29-12-2017 has informed that the above candidates have not joined the said colleges till date;

The above named appointee(s) shall report to the Principal, G.C.E.T, Jammu within a period of 21 days from the date of issuance of this order, they shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

- 1. Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case appointees fails to join within the stipulated period of 21 days, their appointment shall be cancelled without any further notice.

The appointment shall be subject to the following conditions.

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, their appointment shall be deemed to be cancelled ab-initio and he shall have no claim on their appointment.

b) The verification of qualification/ reserved category certificate (wherever

applicable) from the concerned quarters/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.

The appointment of above candidates shall, however, be subject to outcome of writ petition, if any pending in any court of law.

Candidates shall be on probation for a period of two years from the date of joining into Government service and the seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board.
