Subject:- OA.No.1610/2023 titled Arvind Sharma v/s UT of J&K & Ors.

**Government Order No. 190-JK (HE) of 2024  
Dated: 15.03.2024**

**Whereas**, applications were invited through online portal for effecting transfers of Assistant Professors, Associate Professors, Physical Training Instructors and Librarians. Detailed instructions were issued for applying through online Portal;

**Whereas**, the applicant Arvind Sharma, Assistant Professor in Sociology applied through online portal and he was transferred from Government Degree College, Rajouri (Zone C) to Government Degree College Nowshera (Zone C) vide Government Order No. 323-JK(HE) of 2023 dated 15.11.2023;

**Whereas**, the applicant being aggrieved of the Government Order No. 323-JK(HE) of 2023 dated 15.11.2023, filed OA.No.1610/2023 titled Arvind Sharma v/s UT of J&K & Ors before the jurisdictional Tribunal of Hon'ble Central Administrative Tribunal at Jammu praying for following reliefs:-

- i. Quash the impugned Transfer order dated 15.11.2023, to the extent Serial No. 6, whereby the Applicant herein has been transferred from his present place of Posting i.e Government Degree College Rajouri(Zone C) to GDC Nowshera (Zone C).
- ii. Direct the respondents to transfer the applicant from Zone C to Zone B or A in terms of preferences outlined in the representation or in the online portal.
- iii. Pass such other relief which this Hon'ble Tribunal may deem just and proper may also be passed in favour of the Applicants in view of the submissions made herein above.

**Whereas**, the Hon'ble Central Administrative Tribunal after hearing the applicant disposed the OA by passing order dated 12.12.2023, the operative part of which is reproduced as under:

"..... Accordingly, the Original Application is disposed of with a direction to respondents to treat this O.A. as representation of the applicant for his transfer from GDC Nowshera (Zone-C) to any of the colleges of Zone- A or B as per preference given by him in the O.A. and online portal. The respondents shall pass reasoned and speaking order within a period of two weeks from the date of receipt of a certified copy of this order.

With these directions, O.A. No. 1610 of 2023 is disposed of.

It is made clear that I have not entered into the merits of the case

However, there shall be no orders so as to costs.

In the meantime, the status qua be maintained"

**Whereas,** in compliance to the directions of the Hon'ble Central Administrative Tribunal, dated: 12.12.2023, the applicant was requested to appear in the Administrative Department for hearing on 02.02.2024. The applicant appeared on the scheduled date and time and the applicant was heard;

**Whereas,** the applicant has stated that he has been transferred from GDC Rajouri to GDC Nowshera inspite of the fact that the applicant is a resident of Jammu and has completed his tenure in Zone C i.e GDC Rajouri;

**Now therefore,** in the light of the above stated facts and circumstances, the claim of the applicant has been considered and he has been transferred and posted in the Government Degree College, Nagrota, against the available vacancy.
