Cancellation of appointment order of Mr. Jeet Singh S/o Des Raj R/o 130 Village Dhar Ramban under RBA Category for the post of Assistant Professor (English) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No PSC/DR/AP/English/2017 dated 20-08-2021 recommended the name of **Mr. Jeet Singh S/o Des Raj R/o 130 Village Dhar Ramban under RBA Category** along with other 72 selected candidate for appointment as Assistant Professor (English) in pay scale of Rs.15600-39100 with AGP of Rs 6000/-;

Whereas, Higher Education Department vide GO No.88-JK(HE) of 2022 dated 18-04-2022 issued appointment order in favour of Mr. Jeet Singh S/o Des Raj R/o 130 Village Dhar Ramban under RBA Category after getting satisfactory report from CID; the appointee was posted at GDC, Ukhral with the directions to join within a period of 21 days from date of issuance of appointment order failing which the appointment shall be deemed to have been cancelled without any notice; and

Whereas, **Mr. Jeet Singh S/o Des Raj R/o 130 Village Dhar Ramban** has failed to join at Government Degree College, Ukhral within stipulated time as per report of Principal, GDC, Ukhral vide letter No.GDC/UKH/22/147 dated 11.05.2022;

Whereas, as per Circular No. 08 JK(GAD) of 2019 Dated: 04.12.2019 under endorsement No. GAD(Ser)Genl/Circ/06/01 Dated: 04.12.2019 issued by the GAD, it has been provided that the candidates who fail to join within a period of 21 days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled *ab initio* without any further notice.

Now, therefore keeping in view of above, the appointment of **Mr. Jeet Singh S/o Des Raj R/o 130 Village Dhar Ramban** (under RBA Category) as Assistant Professor (English) in Higher Education Department is deemed to have been cancelled *ab initio*.
