Appointment of Technical Assistant Higher Education Department (Divisional Cadre, Kashmir). Operation of waiting list.

Whereas Higher Education Department has referred 05 posts of Technical Assistant (Divisional Cadre, Kashmir) to the Services Selection Board for selection; and

Whereas the Services Selection Board J&K has furnished the panel for the post of Technical Assistant (Divisional Cadre, Kashmir) alongwith waiting list vide their letter No. SSB/Secy/Sel/2017/2311-17 dated 22-02-2017 followed by letter No. SSB/Sel/Secy/2017/1189-91 dated 23-08-2017; and

Whereas, the Higher Education Department accept the recommendation of Services Selection Board J&K and the candidates appointed as Technical Assistant (Divisional Cadre, Kashmir) vide Government Order No. 594-HE of 2017 dated 11-10-2017; and

Whereas the Principal Government College of Education vide his letter No. IASER/17/1108-1109 dated 06-11-2017 intimated that Mr. Qayser Yousuf S/O Mohammad Yousuf Dar R/O Soura Srinagar appointed as Technical Assistant posted in his College vide above referred Government Order did not join within the time period given in the said Government; and

Whereas the case has been examined in the department and it was decided to serve a notice vide letter No. HE-Coll/NGK/KD/2016 dated 11-12-2017 to Mr. Qayser Yousuf S/O Mohammad Yousuf Dar R/O Soura Srinagar appointed as Technical Assistant by giving one more chance to join the College where he have been adjusted within a period of ten (10) days from the date of issuance of this notice falling which his appointment shall be deemed to have been cancelled without giving any further notice; and

Whereas Nodal Officer/Principal Amar Singh College, Srinagar vide his letter No. ASC/Edu/17/2643 dated 26-12-2017 also intimated that Mr. Mr. Qayser Yousuf S/O Mohammad Yousuf Dar R/O Soura Srinagar appointed as Technical Assistant posted in College of Education Srinagar did not join despite lapse of notice served to him; and

Whereas Principal Government College of Education, Srinagar vide letter No. IASE/17/1391 dated 28-12-2017 again informed that despite served a notice given by the Administrative department to Shri Qayser Yousuf vide letter No. HE-Coll/NGK/KD/2016 dated 11-12-2017 through print media directing him to join within a period of ten days, but failed to join the college within the stipulated period; and

The

Whereas, Shri Qayser Yousuf S/O Mohammad Yousuf Dar R/O Soura Srinagar appointed as Technical Assistant vide Government Order No. 594-HE of 2017 dated 11-10-2017; did not join the College despite sufficient time given to him; and

Whereas appointment order in favour of Shri Qayser Yousuf S/O Mohammad Yousuf Dar R/O Soura Srinagar (appointed as Technical Assistant ordered vide Government Order No. 594-HE of 2017 dated 11-10-2017) is hereby cancelled in-abinitio;

Whereas the department has to operate waiting list against the vacancy caused due to non-joining of the above said candidate appointed vide above referred Government Order;

Now therefore as recommended by the Services Selection Board J&K, sanction is hereby accorded to the temporary appointment of Shri Aasif Majeed Sofi S/O Abdul Majeed Sofi R/O Sopore Baramulla as Technical Assistant in the pay scale of Rs. 9300-34800+4200 GP in the Higher Education Department (Divisional Cadre, Kashmir).

The appointee is adjusted in Government Degree College, Sopore and shall report to the concerned College within a period of 21 days from the date issuance of appointment order and he shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

- 1. Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Any other certificate required.
- Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case appointee fails to join within the stipulated period of 21 days, his appointment shall be cancelled without any further notice.

The appointment shall be subject to the following conditions.

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, his

a) appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The order of appointment shall be subject to ab-initio cancellation in case, at any stage, it emerges that the certificates/documents furnished by the appointees are fake/ fictitious.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.

Candidate shall be on probation for a period of two years from the date of joining into Government service and seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board
