Whereas, the Higher Education Department referred 17 posts of Laboratory Assistant (Divisional Cadre, Kashmir) to the J&K Services Selection Board for selection of suitable candidates; and

Whereas the Services Selection Board vide letter No. SSB/Sel/Secy/2015/19632-37 & No. SSB/Sel/Secy/2016/20743-46 dated 31-08-2016 & 08-12-2016 respectively furnished the select list alongwith waiting list for the post of Laboratory Assistant (Divisional Cadre, Kashmir); and

Whereas the Higher Education Department accept the recommendation of J&K Services Selection Board and the candidates appointed were appointed for the post of Laboratory Assistant vide Government Order No. 26-HE of 2017 dated 12-02-2017; and

Whereas the appointees were directed to report to the concerned Colleges where they have been appointed within a period of 21 days from the date of issuance of the above said Government Order, other-wise their appointment order shall be cancelled without any further notice; and

Whereas, Nodal Principal Amar Singh College, Srinagar vide letter No. ASC/Edu/17/1645 dated 25-08-2017 have intimated that the following candidates appointed vide Government Order No. 26-HE of 2017 dated 12-01-2017 have not joined the Colleges where they have been adjusted despite issuance of notice to them on 13-03-2017 through print media to join within a period of 10 days from the date of issuance of this notice; and

Whereas, the General Administration Department vide their U.O No. GAD/Mtg/RB-IV/70/2017 dated 13-10-2017 has advised as under:-

Returned: The department is advised to submit a note to the Hon'ble Chief Minister through Chief Secretary in Coordination for relaxation of sub rule (7) of Rule-14 of the J&K Civil Services and Recruitment Rules, 2010 for re-Decentralization validation/extension in operation of wait list in favour of three (03) open merit list candidates for the post of Laboratory Assistant, Divisional Cadre, Kashmir after cancelling the appointment orders of all the non-joining candidates under OM category. The department is also advised not to invite/seek 2nd wait list of RBA candidates from the J&K Services Selection Board as the recommendations, kept withheld by the Board in respect of the wait list candidates under RBA category, are yet to be released"

Whereas, vide Government Order No. 663-HE of 2017 dated 28-11-2017 wherein the department has cancelled the appointment orders in respect of the above six (06) candidates appointed vide Government Order No. 26-HE of 2017 dated 12-02-2017 for the post of Laboratory Assistant (Divisional Cadre, Kashmir); and

Whereas, the case was again referred to the General Administration Department for re-validation/extension in operation of wait list in favour of three (03) open merit list candidates for the post of Laboratory Assistant, Divisional Cadre, Kashmir; and

Whereas the General Administration Department has vide their O.M No. GDC-302/CM/2017 dated 12-01-2018 has conveyed the approval of the competent authority of the departmental proposal;

Sanction is relaxation of Rule 14(7) of the J&K Civil Services (Decentralization) Recruitment Rules, 2010 notified vide SRO 375 dated 21-10-2010, is hereby accorded to the re-validation of wait list for the post of Laboratory Assistant (Divisional Cadre, Kashmir), recommended by the Services Selection Board vide letter No. SSB/Secy/Sel/2016/19632-37 dated 31-08-2016, against item No. 332, of Advertisement Notification No. 02 of 2011, in respect of following (03) candidate under OM category, beyond the date of its expiry (viz 30-08-2017) upto 31st of January, 2018".

Appointees shall report to concerned College within a period of 21 days from the date of issuance of this order and he shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

- 1. Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case appointee fails to join within the stipulated period of 21 days, their appointment order shall be cancelled without any further notice.

The appointment shall be subject to the following conditions.

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on their appointment.
- b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The order of appointment shall be subject to ab-initio cancellation in case, at any stage, it emerges that the certificates/documents furnished by the appointees are fake/ fictitious.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending, in any court of law.

Candidate shall be on probation for a period of two years from the date of joining into Government service and seniority of the appointees shall be maintained as per merit furnished by the Service Selection Board.
