Whereas, J&K Public Service Commission, vide letter No. PSC/DR/Asstt.Prof./ Economics/13-14 dated 19-05-2017, recommended following candidates for appointment as Assistant Professors (Economics) in Higher Education Department;

- Mr. Mudasir Ahmad Dar S/o Gh Hassan Dar R/o Pombay P/O Gopalpora (D.H. Pura), Tehsil & Distt. Kulgam.
- Mr. Tawseef Ahmad Malik
   S/o Bashir Ahmad Malik
   R/o Village Largam, Tehsil & Distt. Shopian.

Whereas, J&K Higher Education Department vide Government Order No.302-HE of 2017 dated 31-05-2017 accepted recommendations of J&K Public Service Commission and appointed above candidate as Assistant Professor (Economics) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/- and with the direction to report to Nodal Principal, A.S. College, Srinagar within a period of 21 days from date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, vide Government Order No.374-HE of 2017 dated 20-06-2017 both Assistant Professors were posted at Govt. Degree College, D.H. Pura and Govt. Degree College, Charar-i-Sharief respectively; and

Whereas, Nodal Principal, A.S. College, Srinagar vide her letter No.ASC/Edu/17/1543 dated 08-08-2017 intimated that though above Assistant Professors joined at A.S. College, Srinagar for induction programme but failed to join their places of postings at GDC, D. H Pura and GDC, Charar-i-Sharief, therefore exhausted the vacancies which are now lying vacant; and

Whereas, this Department served a Notice vide HE-Coll/Apptt./A.P./Economics/2017 dated 25-09-2017 to above said appointees with directions to join their respective places of postings within a period of 10 days from the date of receipt of Notice or its publication in local News paper uploading on official website of Higher Education Department, whichever happens earlier, failing which their appointment shall be terminated ab-initio without any further Notice; and

Whereas, Principal, GDC, D. H Pura and GDC, Charar-i-Sharief informed that above mentioned Assistant Professors have not joined their services even after sufficient opportunity was granted by Administrative Department.

Now, therefore, appointment of Mr. Mudasir Ahmad Dar S/o Gh Hassan Dar R/o Pombay P/O Gopalpora (D.H. Pura), Tehsil & Distt. Kulgamd (under Open merit category) and Mr. Tawseef Ahmad Malik S/o Bashir Ahmad Malik R/o Village Largam, Tehsil & Distt. Shopian (under RBA category) as Assistant Professors (Economics) in Higher Education Department is hereby terminated in ab-initio.
