Whereas, the Ministry of Human Resources and Development (MHRD), Government of India (GOI) approved two Government Colleges of Engineering and Technology, one each at Janglote in Kathua district and at Safapora in Ganderbal district during 2014 under the component 'New Professional Colleges' of the Centrally Sponsored Scheme "Rashtriya Uchchattar Shiksha Abhiyan" (RUSA) for addressing critical gaps in spatial distribution of higher educational institutions across the State;

Whereas consequent to the sanction of the engineering colleges, the State Cabinet vide decision No. 170/11/2017 dated 03-10-2017, approved establishment of two Government College of Engineering and Technology (GCET) one each at Janglote Kathua and Safapora Ganderbal under RUSA;

Whereas, it was later on decided by the Hon'ble Governor, with the then Hon'ble Education Minister and Principal Secretary to Government, Higher Education Department, Principal Secretary to Hon'ble Chief Minister that GCET Janglote shall be allowed to function as constituent college of the University of Jammu.

Whereas, in pursuance to the above decision, the State Administrative Council, vide its decision No. 53/7/2019 dated 28-02-2019 has formally approved to transfer the Government College of Engineering and Technology Janglote (Kathua) to the University of Jammu to function as its constituent college.

Now, therefore, sanction is accorded to the transfer of Government College of Engineering & Technology, Janglote, Kathua along with infrastructure created under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) to University of Jammu for its functioning as a constituent college of the University in the name of University Institute of Engineering and Technology (UIET), Janglote, Kathua.
