Subject: Placement of Faculty members of GCET Jammu in next higher pay scales/ pay bands under Career Advancement Scheme.

Reference:- Minutes of the DPC meeting held on 15-03-2018 .

Government Order No: 174- HE of 2008. Dated: 16 - 03-2018.

- Whereas, Government College of Engineering and Technology Jammu was established vide Government Order No:413 Edu(Tech) 1993 Dated:22-09-1993 along with creation of faculty positions/ supporting staff;
- Whereas, in absence of requisite Departmental Recruitment Rules, faculty positions created for the College, were filled up through J&K PSC, in accordance to eligibility criteria prescribed by All India Council for Technical Education, (AICTE);
- Whereas, framing of Departmental Recruitment Rules (Gazetted) for GCET Jammu remained under consideration in the Department upto 07/2017 and were finally notified vide SRO 272 of 2017;
- 4. Whereas, State Finance, Department notified J&K College of Engineering and Technology Teachers (adoption of AICTE Revised Pay Scales) Rules, 2006, vide SRO 61 of 5th March 2007, which came into force w. e. f. 01. 01.1996, with the provision for placement of faculty members in higher pay scales under Rule 10, under Career Advancement scheme (CAS);
- Whereas, Principal, GCET Jammu vide No: GCET/07/1471 dated: 08-08-2007, submitted cases of eligible faculty members for placement in higher levels under provisions of SRO 61 dated: 5th March 2007, which remained under consideration in the Department but the same got destroyed in fire incident of year 2013;
- 6. Whereas, during year 2013, State Finance Department notified revised J&K College of Engineering and Technology (Adoption of AICTE revised pay scales) Rules, 2013 vide SRO 235 of 25th April 2013, which came into force from 01-01-2006, with effective date of implementation as 01-08-2009, with provision for placement of faculty members in the higher pay scales / pay bands under rule 10, (Career Advancement scheme);
- 7. Whereas, due to delay in re-construction/consideration of placement cases, aggrieved faculty members of GCET Jammu approached Hon'ble Court and filed a writ petition, SWP No.1044/2014, MP No.1376 / 2014 and MP No. 01 of 2017, that was contested by the Department. However, Hon'ble Court in its Judgment dated 12-07-2017 disposed off the petition along with connected MP(s) with the direction that respondents shall pass appropriate consideration order within a period of six weeks;
- 8. Whereas, cases of eligible faculty members were placed before DPC constituted vide Government Order No 270-HE of 2014 dated: 22-05-2014 for examination/Consideration under rules;
- 9. Whereas, the DPC during its meeting held on 15-03-2018, examined the cases of eligible faculty members in light of relevant rules, prescribed under J&K College of Engineering and Technology teachers (adoption of AICTE Revised Pay Scale) Rules, 2006 notified under SRO 61 of 5-3-2007 read with J&K College of Engineering and Technology teachers (adoption of AICTE Revised Pay Scale) Rules, 2013 notified under SRO 235 of 25-4-2013 and after scrutinizing all cases, recommended placement of various Assistant Professors of GCET Jammu in the higher pay scales / pay bands under rules ; and
- 10. Now, therefore on the recommendations of Departmental Promotion Committee, sanction is hereby accorded to placement of following faculty members in next higher pay scales/ Pay bands from the dates shown against each as below:-
