Sanction is hereby accorded to the temporary appointment of Sh. Kamal Kumar S/o Krishan Lal R/o Vill-Khour Deonian P/O Khour Deonian Tehsil R.S Pura (Divisional Cadre Kashmir in the pay scale of Rs. 5200-20200+GP 2400 (Pre-revised) in the Higher Education Department.

Appointee shall report to the Principal Government College for Women, M.A Road, Srinagar within a period of 21 days from the date of issuance of this order and he shall be allowed to join only on production of following certificate/documents in original, which shall be verified subsequently from the concerned quarter.

- 1. Academic/Technical qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the competent Authority.
- 4. Permanent Resident certificate.
- 5. All other relevant certificate.
- 6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.

In case appointee fails to join within the stipulated period of 21 days, his appointment shall be cancelled without any further notice.

The appointment of above candidate shall governed by the "Jammu and Kashmir Special Recruitment Rules" as per SRO-202-2015 dated. 30/06/2016.

The appointment shall be subject to the following conditions:-

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that the case adverse report about his character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the concerned Principal, his appointment shall be deemed to the be cancelled ab-initio and he shall have no claim on his appointment.

b) The verification of qualification/reserved category certificate (whenever applicable from the concerned quarter/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The inter-se- seniority of the appointee shall be drawn as per merit furnished by the service Selection Board J&K.

Further, if on verification, at any stage the certificate produced by the appointee is found fake or forged, the appointment shall be treated as cancelled abi-initio.

The appointment of the above candidate shall be governed by new pension scheme as per SRO-400 of 2009 dated. 24.12.2009.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.
