- c. Their salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.
- d. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24/01/2009.
- e. The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the Nodal Principal GGM Science College Jammu:

 - ii. Date of Birth Certificate.
 - iii. Qualification Certificates i.e. NET/SLET/Ph.D
 - iv. Category certificate as may be applicable to the appointee.
 - v. A certificate from the Director Employment that the candidates has liquidated loan taken if any.

The inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any pending, before any court of law.
